9.0 Board Report Board chair member: Lorraine Stewart

Quality Learning, Student Success and Wellbeing:

- **Facilities Services Report:** a detailed report was given by our Facilities Department on the many and varied projects they have completed or are in the process of completing over the summer and into the fall. At Forest Green School, boilers and associated pumps were replaced and an outdoor classroom was built and landscaping completed - this was a joint PSD and School Council effort - thanks!
- **Off-Site Activities Report:** a detailed report on 39,000 off-site (field trip and international trips) was provided and reflects the importance we give to having off-site experiences for our students that are connected to curriculum outcomes. Staff are to be commended for organizing these activities.
- The **Superintendent** reported that food security and food supports will still be an area of focus this year as well as increased mental health supports with added nursing supports; specialized assessment grants have been renewed for this school year.
- **Curriculum:** new curriculum in math and language arts K-6 and science and French Immersion K-3 will be implemented this school year. The Minister of Education has announced that there will be fulsome discussion and input gathered regarding the Social Studies curriculum. A letter will be sent to parents.

Trustees Engage, Listen and Advocate

- **Governance Budget Allocation for School Councils:** The Board sees the value and benefit of development for School Councils. The Board passed a motion to allocate up to \$6000 of our Governance Budget to financially support attendance for representatives from school councils to attend the 2024 Alberta School Council Association conference.
- **Transportation:** The Superintendent reported that this year, there are 170 bus routes with about 7400 students riding those buses. As of September 12, 2023 there were 9 routes without a permanent driver (6 covered by substitute drivers and 3 covered by double runs). The Board will be represented at the upcoming Alberta Student Transportation Advisory Committee meeting on September 21, 2023 to express our concerns. The Minister of Education will be in attendance to listen to concerns about this provincial issue.

- **Spruce Grove Composite High School** is proceeding with design funding meetings with Alberta Education, Alberta Infrastructure and PSD.

Trustees Foster Community Relationships

- Sept. 29/23 is our Orange Shirt Day with a whole week focused on Truth and Reconciliation activities; our First Nation Advisory Committee will have their first meeting Sept. 26/23.
- A Stronger Together monthly newsletter is available on the PSD website. This newsletter is prepared by Jenn Goulden and Fristy Thomas, Divisional Family Support Coordinators and contains information that can help families navigate their children’s educational journey.
